- **ABSOLUTELY NO** obscene or offensive lyrics will be allowed. Indecent or obscene gestures will not be permitted.

- Microphones, sound and lighting will be provided by the organizer. Band members must bring their own personal instruments including amplifiers and drums.

- Bands must perform by self, i.e.; no backup band or prerecorded music is allowed.

- Bands selected to compete will be notified by September 15, 2010. Bands will be included in event promotions after that date. A contestant package will be mailed to the band to include the schedule, additional rules, PA provisions, and admission for the band members.

- All bands agree to have their name, voice and/or likeness used in any advertising or broadcasting material related to this contest without any compensation or rights to royalties for such use.

- Bands in violation of eligibility requirement will be disqualified and any prize monies will be forfeited.

- Wilson County Fair is not responsible for damage or theft of personal property.

- Abuse or theft of provided equipment will result in immediate disqualification and reparation to the equipment provider.

- Judging will be based on a panel of judges, scoring musicians on a point system. Each act will be judged on the following criteria: Stage Presence - appearance, appropriate material; Time - use of time; Originality - quality original material and/or interpretation of cover tunes; Music Ability - vocal/instrumental skills, intonation, complexity of music; Audience Approval - applause, overall enthusiasm

- Fires, pyrotechnics, fog machines, etc. are NOT allowed.
